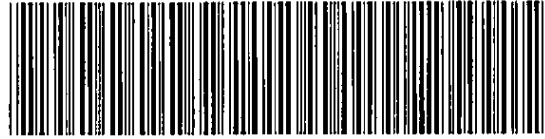

The specific purpose for which this corporation is organized is : To empower individuals and communities to achieve financial security and stability by providing access to affordable financial education and resources. Our mission is to promote economic equity by serving low- and moderate-income individuals and families, and to contribute to the overall well-being of the communities we serve.

Brighter Futures Financial Inc is organized exclusively for charitable, literary, and educational purposes, including for such purposes the making of distributions to organizations that qualify under section 501(c)(3) of the Internal Revenue Code or any corresponding section of any future federal tax code.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the IRC, or corresponding section of any future tax code, or shall be distributed to the federal government, or to state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively of such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.




