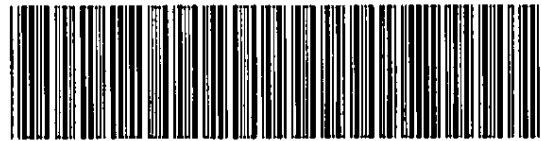

## ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

### ARTICLE I      NAME

The name of the corporation shall be Miracles Dance Team Booster Club, Inc.

### ARTICLE II      PRINCIPAL OFFICE

### ARTICLE III      PURPOSE

The organization is organized and operated for the charitable purposes of supporting the Dance Team at Melbourne High School within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. This support will be accomplished by recruiting volunteers, raising funds, and hosting charitable events. Donations and contributions will be used for costs/items including, but not limited to, participant uniforms, production costumes, supplies and equipment, fees and costs associated with participation in competitions and the hosting of dance camps, choreography/music costs and any other cost deemed necessary to support the program. The organization will conduct fundraising, the types of which shall be determined, throughout the year to generate these funds.

The corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code. (All references to sections in these Articles refer to the Internal Revenue Code of 1986 as amended or to comparable sections of subsequent internal revenue laws.) In pursuance of these purposes, it shall do all things necessary, proper, and consistent with maintaining tax exempt status under section 501 (c)(3).

**ADDITIONAL PROVISIONS**

No part of the net earnings of the corporation shall inure to the benefit of or be distributed to any director, employee or other individual, partnership, estate, trust or corporation having a personal or private interest in the corporation. Compensation for services actually rendered and reimbursement for expenses actually incurred in attending to the affairs of this corporation shall be limited to reasonable amounts. No substantial amount of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and this corporation shall not intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles or of any Bylaws adopted thereunder, this corporation shall not take any action not permitted by the laws which then apply to this corporation.

Upon dissolution of the corporation, its assets shall be disposed of exclusively for the purposes of the corporation or distributed to such organizations organized and operated exclusively for charitable purposes which shall, at the time, qualify as exempt organizations under section 501(c)(3), or shall be distributed to the federal government, or to a state or local government, for a public purpose.
