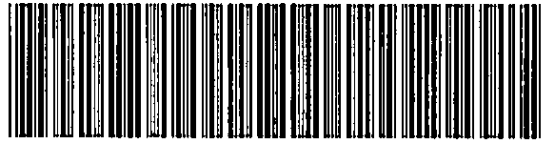

Purpose and Dissolution Clause as required by IRS

Purpose Clause:
