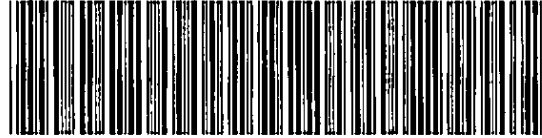

**Articles of Incorporation of Florida-Georgia Lutheran Early Response, Inc.**

The undersigned, citizens of the United States and the State of Florida, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida do hereby certify:

**Article I – Name**

The name of the Corporation shall be Florida-Georgia Lutheran Early Response, Inc.

**Article II – Principle Office**

The place in this state where the principal office of the Corporation is located is the City of Orlando, Orange County, State of Florida.

**Article III – Purpose**

The purpose of the Corporation is primarily that of providing disaster response assistance, training, and planning, and to engage in any lawful act or activity for which corporations may be organized under the laws of State. Florida-Georgia Lutheran Early Response, Inc. is organized exclusively for charitable, religious, and educational, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article IV – Manner of Election**

Directors of Florida-Georgia Lutheran Early Response, Inc. shall be elected by a majority vote of the entire Board of Directors, as further defined in the Bylaws.

#### Article VIII – Restrictions

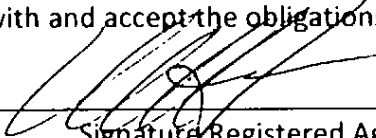
No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in, including the publishing or distribution of statements, any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

### Article IX – Dissolution


Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Having been named as registered agent and to accept service of any process for the above stated corporation at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent.
