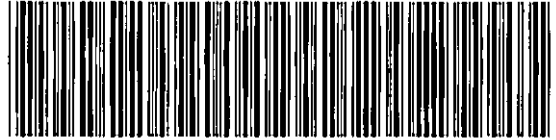

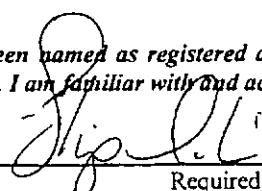

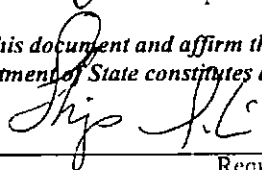

ARTICLES OF INCORPORATION

OF

We the undersigned, all of whom are of legal age, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, applicable to corporation not for profit, under the following Charter

ARTICLE I

The name of the corporation shall be COAST TO COAST VETERANS CLUB OF JAX, INC.

ARTICLE II

The principal place of business of the corporation shall be at 5391 Collins Road,, Jacksonville, Florida 32244 and the mailing address shall be 5391 Collins Road, Jacksonville, Florida 32244
