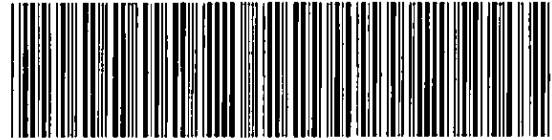

Amending Article IV and Adding additional articles IX and X

Article IV

The directors shall be elected by a majority vote and the corporation will have no members.

Article IX

Below are the provisions regarding the distribution of the corporation's assets upon its dissolution.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Article X

Any other provisions which the corporation elects to include are attached.

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

More specifically, the organizations mission is to establish a Church Ministry which will empower through education, housing, financial literacy, veteran assistance, community and business development, strategic planning while fostering growth to become self reliant through biblical perspectives in order to become economic producers within the community.


