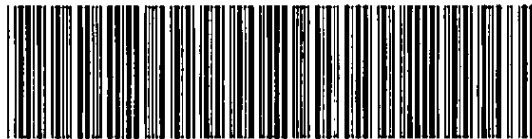

Please amend Article 3 Purpose to read as follows:


Article 3. Purpose.
