ARTICLES OF INCORPORATION OF CORWIN DRIVE MAINTENANCE ASSOCIATION, INC.

In compliance with the requirements of Chapter 617, Florida Statutes, the undersigned, being a resident of the State of Florida and of full age, hereby forms a corporation not for profit in accordance with the laws of the State of Florida, and certifies as follows:

ARTICLE I - NAME

The name of this corporation is **CORWIN DRIVE MAINTENANCE ASSOCIATION**, **INC**. (this or the "Association").

ARTICLE II - PRINCIPAL OFFICE

The initial principal office of this Association shall be located at 1592 Marion Court, Tallahassee, Florida 32303, which office may be changed from time to time by action of the Board of Directors of the Association.

ARTICLE III - REGISTERED OFFICE AND AGENT
