## ARTICLES OF INCORPORATION OF WAT BUDDHA BOONYA, INC.

Pursuant to Section 617.0202, Florida Statutes, the Articles of Incorporation of WAT BUDDHA BOONYA, Inc., a Florida corporation not for profit, is hereby incorporated. The Articles of Incorporation shall henceforth be as follows:

### ARTICLE I

NAME: The name of the corporation is WAT BUDDHA BOONYA, Inc., its principal place of business is 1394 Platt Road, Naples, Florida 34120, and its mailing address is 869 103<sup>rd</sup> Avenue N. #10, Naples, Florida 34108, unless otherwise changed by the Board.

### ARTICLE II

PURPOSE AND POWERS: The purpose for which WAT BUDDHA BOONYA, Inc. is organized and operated exclusively to own and operate a place of worship, specifically a Thai Buddhist Temple. The corporation is organized and shall exist on a non-stock basis as a corporation not for profit under the laws of the State of Florida, and no portion of any net earnings of the corporation shall inure to the private benefit of any private member, Director, officer, or other individual. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

### ARTICLE III

DISSOLUTION: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

### ARTICLE IV

#### DIRECTORS AND OFFICERS:

- (A) The affairs of the corporation shall be administered by a Board of Directors consisting of the number of Directors determined by the Bylaws, but in no event less than three (3) Directors;
- (B) Directors of the corporation shall be elected by the members in the manner determined by the Bylaws. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided by the Bylaws.
- (C) The business of the corporation shall be conducted by the officers designated in the Bylaws. The officers shall be elected each year by the Board of Directors at its first

meeting after the annual meeting of the Members of the corporation, and shall serve at the pleasure of the Board.

#### **ARTICLE V**

#### **ARTICLE VI**

**REGISTERED AGENT:** The street address of the initial registered office of WAT BUDDHA BOONYA, Inc. is 869 103<sup>rd</sup> Avenue N. #10, Naples, FL 34108, and the name of the initial registered agent of WAT BUDDHA BOONYA, Inc. at that address is Sathit Boonyavairoj.

#### **ARTICLE VII**

**INCORPORATOR:** The name and residence of the Incorporator is as follows:

The rights and interests of the incorporator shall automatically terminate when these Articles are filed with the Secretary of State.

#### **ARTICLE VIII**

**INDEMNIFICATION:**

(A) WAT BUDDHA BOONYA shall indemnify any past or present director, officer, employee or agent of the corporation, and any person who may have served or who serves at its request as a fiduciary, against

1. any expenses and costs, including but not limited to legal and accounting fees, incurred in connection with any claim asserted against him by reason of being or having been such director, officer, employee, agent or fiduciary or in connection with any civil or criminal action, suit or proceeding which is instituted before any court or administrative body and to which he is made a

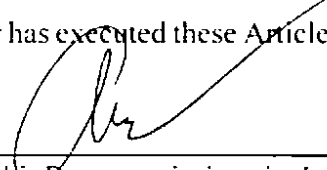
party by reason of being or having been such director, officer, employee, agent or fiduciary;

2. any amounts paid in settlement of any such claim or any such action, suit or proceeding; and
3. any amounts paid on any judgments rendered in any action, suit or proceedings;

provided that he acted in good faith and in a manner he reasonably believed to be in, or not opposed to, the best interests of the corporation and, with respect to any criminal action or proceeding, had no reasonable cause to believe his conduct was unlawful. In no event, however, shall indemnification be made for any expenses incurred in connection with any claim or liability as to which it shall be adjudged that such person is liable for willful misconduct in the performance of his duties. The indemnification provided by this Article shall be in addition to any other rights which those indemnified may have under any law, agreement or resolution of the Board of Directors.

- (B) The corporation shall be authorized to maintain acceptable insurance or other surety for the purpose of indemnifying the Board, its Directors, and such other persons as necessary subject to the limitations in this Section.
- (C) Any indemnification under subsection (A) shall be made by the corporation only upon a determination that indemnification is proper in the specific circumstances because the applicable standard of conduct set forth in subsection (A) has been met, made by a majority vote of a quorum of Directors who were not parties to such action, suit or proceeding and supported by legal counsel in a written opinion.

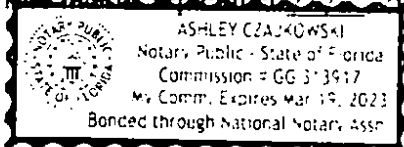

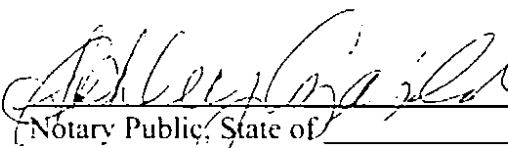

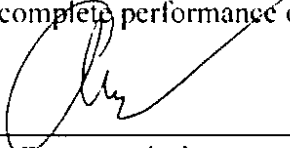
