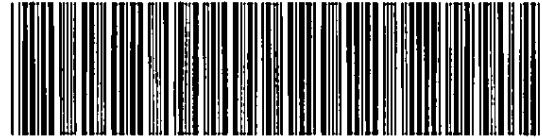

**ARTICLES OF INCORPORATION
OF

Article I

Name

The name of the Corporation shall be New St. Paul Missionary Baptist Church of Newberry, Inc. (the "Church")

Article II

Principal Office and Mailing Address

The physical address of the principal office of the Church shall be 25213 NW 8th Ave, Newberry, Florida 32669, and the mailing address shall be Post Office Box 1512, Newberry, Florida 32669

Article III

Purpose

This Church is a not-for-profit corporation, organized and to be operated exclusively for religious and charitable purposes, within the meaning of Section 501© (3) of the Internal Revenue Code of 1986, as amended (the "Code"), and not for pecuniary profit. More specifically, the Church is organized as a religious ministry available to all individuals of similar faith and is organized to conduct any and all lawful affairs and businesses incident to the operation of a religious ministry.

The Pastoral Leadership team of the Church shall act as the governing authority by providing spiritual guidance, setting major policies, and exercising responsibility for the business and activities of the Church. The officers of the Church shall be the Pastor and members of the Pastoral Leadership Team and shall consist of a least three members of all times. The number of officers may be increased or decreased from time to time as set forth in the Bylaws of the Church but must always be at least three. 
Article VIII Dissolution

Upon the dissolution of the Church, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Church shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes, and which has established its tax-exempt status under Section 501 © (3) of the Code (or the corresponding provision of any future federal tax laws), as determined in the Bylaws of the Church.

Article IX
Limitations

No part of the net earnings of the Church shall inure to the benefit of its directors, officers, or other private persons, except that the Church shall be authorized to pay reasonable compensation for services rendered and to make payments in furtherance of any of its charitable purposes. No part of the activities of the Church shall be the carrying on of propaganda, or otherwise attempting except to influence legislation (except as otherwise provided in subsection (b) of Section 501 of the Code), and the Church shall not participate or intervene in any political campaign on behalf of any candidate or public office. Notwithstanding any other provision of these Articles, the Church shall not carry on any activities not permitted to be carried on (a) by a corresponding provision of any future federal tax law), or (b) by a corporation contribution to which are deductible under Section 170(c)(2) of the Code (or the corresponding provision of any future federal tax law).


