Reviving The World Inc.

ARTICLE III

Section 1:

This corporation is organized and operated exclusively for one or more of the following purposes: Charitable, Educational, Scientific and/or Religious. This includes the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The specific purpose is the promotion of religion, which includes the following:

- Preparing and conducting Christian events, crusades, and church services at home and abroad, usually in cooperation with the various local churches and congregations;
- Organizing mission partner conferences at home and abroad;
- Teaching seminars at home and abroad, especially for spiritual leaders of the various Christian churches;
- Preaching at services in churches and congregations at home and abroad, as well as participation in or support of such events;
- Support and promotion of the founding of Christian congregations at home and abroad;
- Dissemination of Christian information and teaching material in the form of publications, films and other media;
- The organization may cooperate with other organizations in the USA and abroad that pursue similar purposes in order to achieve its goals;
- Raising of funds for the promotion of the above-mentioned purposes in accordance with the Articles of organization, in the USA by tax-privileged corporations and corporations under public law and abroad by foreign corporations that use their funds for purposes that are likewise tax-privileged in terms of the Fiscal Code. In this respect, the organization also acts as a sponsoring association;
- Facilitating and running training centers to equip, empower, and send out evangelists.

Section 2:

No part of the net carnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of the document, the

organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Section 3:

Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for religious, charitable, educational, literary, and scientific purposes and which has established its tax exempt status under Section 501 (c) (3), Internal Revenue Code.
