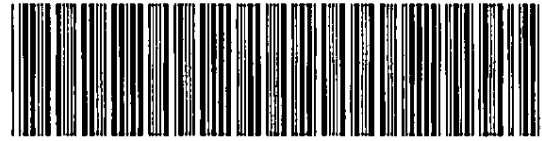



**ARTICLES OF INCORPORATION
(Not for Profit)
OF

Article I – Name

The name of the Corporation shall be Church of Top Christian Ministry of Deliverance, Inc.

Article II – Address of Corporation

The principal address of the Corporation and the mailing address shall be:

Article III - Purpose

The specific purpose for which this Corporation is organized is to establish a congregational church of God. The church, and its devoted members, will strive to serve, teach, preach, heal and deliver each other, and the local community, according to principles laid out in the Biblical scriptures and the teachings of our Lord, Jesus Christ. The Church, and its members, will also seek to serve the community by providing food assistance, as resources will permit.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
