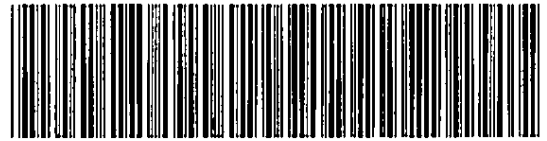

As a means of accomplishing the above purposes, the Corporation shall have the following powers: (a) to receive and accept gifts of money and property and to hold the same for any of the purposes of the Corporation and its work; (b) to raise and assist in raising funds for the purposes herein set forth; (c) to acquire, own, lease, mortgage and dispose of property both real and personal; and (d) to accept property and donations in trust for religious or charitable purposes.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to any private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.
