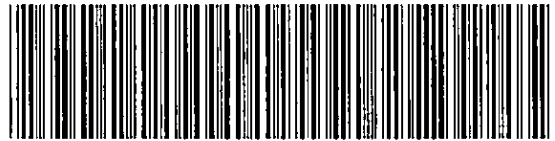

The undersigned, being the Incorporator and a Director of the corporation, hereby submits the following Articles of Amendment to its Articles of Incorporation, in accordance with the provisions of the laws of the state of Florida for the formation of corporations not for profit, Chapter 617, Florida Statutes:

1. The name of the corporation is: BUILDING HOPE, INC.
2. Article IX of the corporation's Articles of Incorporation is hereby deleted in its entirety.
3. Article XI of the corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:

11.01. **AMENDMENT**. These Articles may be amended in the manner provided by law; provided, however, that any such amendment shall require the affirmative vote of at least two-thirds (2/3) of the then incumbent members of the Board of Directors.

4. The date of the amendment's adoption is June 3, 2024.
5. The amendment was adopted by at least two-thirds (2/3) of the Board of Directors.
