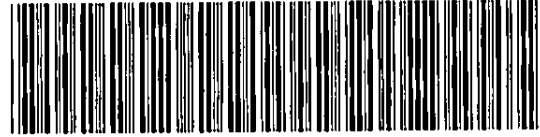

The undersigned, being the Incorporator and a Director of the corporation, hereby submits the following Articles of Amendment to its Articles of Incorporation, in accordance with the provisions of the laws of the state of Florida for the formation of corporations not for profit, Chapter 617, Florida Statutes:

1. The name of the corporation is: BUILDING HOPE, INC.
2. Article VII of the corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:

7.01. **DIRECTORS**. The powers, business and affairs of the corporation shall be managed and directed by the Board of Directors in accordance with these Articles and the Bylaws. The corporation initially shall have five (5) directors. The number of directors may be increased or decreased from time to time by amendment to the Bylaws but there shall at all times be at least three (3) directors. The method of electing the directors shall be as provided in the Bylaws. The initial directors are:

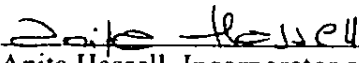
