The Corporation is organized and shall be operated on a not-for-profit basis and exclusively for social welfare within the meaning of Section 501(c)(4) of the Internal Revenue Code (or the corresponding provisions of any future United States federal tax law). The organization will operate primarily to further the common good and general welfare of the people of the community (such as by bringing about civic betterment and social improvements).

The specific purposes of this Corporation is: To ensure that safety, property values and appealing neighborhood features within Hernando Oaks are safeguarded, by 1) monitoring the decisions or lack of decisions made by entities impacting the community, 2) scheduling homeowner events and recommending neighborhood improvements and 3) taking appropriate action when necessary to preserve the communities wellbeing. Further, the Corporation will be devoted to preserving the community's traditions, architecture and appearance by representing it before the local legislature and administrative agencies in zoning, traffic and parking matters. This organization is formed to promote the legal rights of all Homeowners in the Hernando Oaks community located in Hernando, FL.

As a Section 501(c)(4) social welfare organization, the organization may engage in some political activities, so long as that is not its primary activity. However, any expenditure it makes for political activities may be subject to tax under IRS code.

Seeking legislation germane to the organization's programs is a social welfare purpose for this Corporation. Further, if the organization engages in lobbying, it will provide notice to its members regarding the percentage of funds paid that are applicable to lobbying activities or pay a proxy tax.

As a tax-exempt social welfare organization described in Internal Revenue Code (IRC) section 501(c)(4), this organization will operate exclusively to promote social welfare. The earnings of the organization may not inure to the benefit of any private shareholder or individual.

Although the Corporation qualifies for federal tax exemption under 501(c)(4), charitable contributions are not tax deductable to the Corporation. Correspondingly, donations to the Corporation are not tax deductable to donors for income tax purposes.

Once the organization is dissolved, all remaining assets will be distributed back to its contributors.
