Article IX - Dissolution

1. The dissolution of the flight club may be initiated by a majority vote

of the managing members, or by a written consent of all members.

2. Upon initiation of dissolution, written notice shall be given to all members, creditors, and any

other parties with whom the flight club has ongoing obligations or contracts.

3. The flight club shall cease all operations except for those activities

necessary to wind up and liquidate its business and affairs.

4. The assets of the flight club shall be liquidated in the following order of priority:

a. Payment of all liabilities and obligations of the flight club.

b. Reimbursement of any members for documented investments made into the flight club.

c. Distribution of any remaining assets shall be distributed for one or more exempt purposes within the meaning

of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be

distributed to the federal government, or to a state or local government, for a public purpose

5. A final report summarizing the dissolution process, including the handling of assets and

distribution of funds, shall be prepared and made available to all members.

6. The necessary documentation to officially dissolve the flight club shall be filed

with the appropriate state authorities to finalize the dissolution process.
