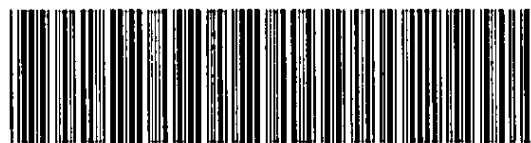

**ARTICLE I

- (c) The **IGLESIA PENIEL INTERNACIONAL TAMPA, FL., Inc.**, reaffirms itself in the proclamation of one God by Jesus Christ, his son, as Savior, in preaching the sound evangelical doctrine, in perfecting the SANCTIFICATION of the body and spirit, and in the necessity of seeking THE baptism of the Holy Spirit, and rejecting any unity with entities that adulterate the Holy word of God.

## **ARTICLE VI MARRIAGE**

All the ministers, without any exception, are prohibited from celebrating (same sex) matrimonies homosexuals or lesbians. The ministers that were to be found celebrating such an act will be immediately expelled from **IGLESIA PENIEL INTERNACIONAL TAMPA, FL., Inc.**

## **ARTICLE VIII CHURCH GOVERNANCE**

## **ARTICLE IX PROPERTY**

- a. Manner in Which Held: All real and personal property shall be held exclusively in furtherance of the purposes of The **IGLESIA PENIEL INTERNACIONAL TAMPA, FL., Inc.**



- b. In the Event of Dissolution: In the event of the disbanding of this Church and the dissolution of this corporation, the Church remaining assets, if any, after the payment of its debts and expenses, shall be conveyed as the board of trustees may propose and as the affirmative vote of a majority of the members shall determine, subject to each of the following:
1. The classis must approve the disbanding of this Church and the dissolution of this corporation:
  2. The board of trustees shall consult with the classis in formulating its proposal for property distribution.
  3. The vote of the members shall be in accordance with the provisions in these Articles of Incorporation.
  4. All remaining assets must be distributed only to one or more organizations, which qualify as exempt organizations under Section 501c(3) of the Code.

- b. To borrow money, issue bonds, debentures, notes or other obligations, secure for monies so borrowed or in payment for property, or for any of the purposes stated herein.
- c. No person shall, on the ground of race, color, or national origin, be excluded or denied the attendance to, or be subjected to any discrimination whatever, with respect to any and all of the services rendered by this Corporation.
- d. To do and perform any and all other acts necessary of convenient to the accomplishment of the foregoing purposes, whether specifically enumerated herein or not.

- e. To have and to exercise all powers and authority conferred by the laws of the State of Florida.
- f. Notwithstanding the foregoing, or any other provision of these Articles of Incorporation, this corporation shall not carry on any activity not pennitted to be carried on by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal revenue law.)
- g. This Corporation shall have no capital stock.
