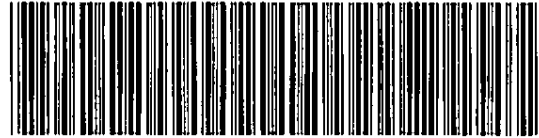

OF

The under signed persons, acting as Incorporators of a corporation not for profit under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopt the following Articles of incorporation for such corporation.

ARTICLE I

The name of the corporation: **1 Step Forward, Inc.** (hereinafter referred to as the "Corporation").

ARTICLE II

The purpose of this Corporation shall be:

- 1) To assure the availability of readily accessible quality health services as required and in a way that assures the dignity and respect of the individual consumer and provider and at a cost they can afford.
- 2) To operate a comprehensive health center.
- 3) To provide disabled persons, low income families and elderly persons with services specially designed to meet their physical, social, and psychological needs, and to promote their health, security and happiness in longer living. The charges for such facilities and services to be predicated upon the provision, maintenance, and operation thereof on a non-profit basis.

ARTICLE III

The Directors of this Corporation are to be elected/appointed as set forth in the Bylaws.

ARTICLE IV

The term for which this Corporation shall exist shall be perpetual.

ARTICLE V

The corporate powers of this Corporation are as provided in Section 617.0302, Florida Statutes.

ARTICLE VI

The principal office of the Corporation and place of business and mailing address is 13881 Carolina Laurel Drive; Orlando, Florida 32828.

ARTICLE VII

The powers of this Corporation shall be exercised, its property controlled, and its affairs conducted by a Board of Directors. The number of Directors of the Corporation shall not be less than three; provided, however, that such number may be increased from a minimum of three by changing the bylaw duly adopted pursuant to the Bylaws of this Corporation. The Directors named herein as the first Board of Directors shall hold office until the first election of Directors at the Corporation's first annual meeting of members. Directors elected at the first annual meeting, and at all times thereafter, shall serve for a term of one year until the annual meeting of members following the election of Directors and until the qualification of successors in office. Annual meetings shall be held at the time and place designated by the Board of Directors. Any action required or permitted to be taken by the Board of Directors under any provision of law may be taken without a meeting, if all the members of the Board shall individually or collectively consent in writing to such action. Such written consent or consents shall have the same force and effect as if taken by unanimous vote of the Directors. Any certificate or other document filed under any provision of law that relates to action so taken shall state that the action was taken by

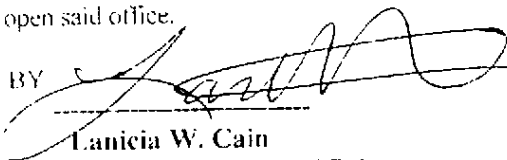
