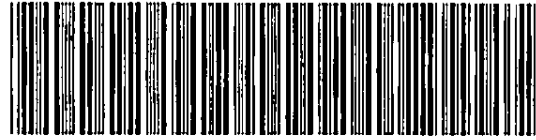

Article I  
*Name*

The name of this Florida "Not For Profit" Corporation is **Team First Glove Boxing, Inc.** (hereafter "Team First Glove").

Article II  
*Principal Office*

Team First Glove's principal office is located at 5330 Ehrlich Road, Unit 130, Tampa, Florida 33624.

Article III  
*Purpose*

The purpose for which Team First Glove is organized is for charitable and educational purposes as specified in Section 501(c)(3) of the Internal Revenue Code. Further, Team First Glove is organized and operated to foster, support and develop amateur athletes for local, regional, state, national and international amateur boxing competitions.

Article IV  
*Manner of Election*

The manner in which the directors are elected and appointed shall be stated in the bylaws of Team First Glove.

Article VIII  
*Effective Date*

The effective date of Team First Glove shall be October 22, 2022.

Article IX  
*Prohibited Activity*

**NO PRIVATE INUREMENT:** Team First Glove is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. Team First Glove shall not distribute any gains, profits or dividends to the Directors, Officers or Members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying out the corporation's charitable, educational and amateur boxing purposes. The property, assets, profits and net income of Team First Glove are irrevocably dedicated to charitable, educational and amateur boxing purposes; no part of which shall inure to the benefit to any individual.

**LOBBYING AND POLITICAL CAMPAIGNS:** No substantial part of the activities of Team First Glove shall consist of the carrying on of propaganda or otherwise attempting to influence legislation; and the corporation shall not participate in, or intervene in any political campaign on behalf of any candidate for public office.


Article X  
*Dissolution Clause*

Upon dissolution of Team First Glove, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. Any assets not so disposed shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is located, as listed in Article II herein. Disposal shall be made exclusively for exempt or public purposes, or be made to such organization or organizations as the court shall determine to be organized exclusively for such purposes.

Article XI  
*Indemnification*

Pursuant to §617.0831, Fla. Stat., any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit or proceeding by reason of the fact that he/she is or was a Director, Officer or Member of Team First Glove shall be indemnified by the corporation against any and all liability and the reasonable expenses, including attorney's fees and costs, incurred by such person in connection with the defense or settlement of such action, suit or proceeding, or in connection with any appearance, therein, except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that such person is individually liable for negligent or intentional misconduct in the performance of his/her duties with or on behalf of the corporation.

***Having been named as Registered Agent to accept service of process for the above-stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as Registered Agent and agree to act in this capacity.***
