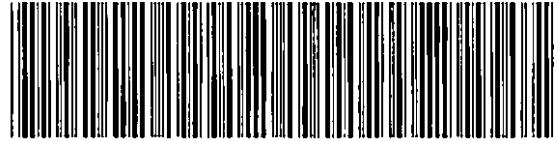

**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
INDIGENOUS DERMATOLOGY, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Not For Profit Corporation Act, **INDIGENOUS DERMATOLOGY, INC.**, a Florida not-for-profit corporation (the "Corporation"), adopts the following Articles of Amendment to the Articles of Incorporation effective December 1, 2022 (the "Effective Date").

A. Article I of the Articles of Incorporation is deleted in its entirety and replaced as follows:

ARTICLE I

NAME AND ADDRESS


The name of this corporation shall be Indigenous Dermatology, Inc. (the "Corporation"). The physical address of the Corporation's principal office shall be at 601 Brickell Key Drive, Suite 700, Miami FL 33131. The mailing address of the Corporation shall be at 601 Brickell Key Drive, Suite 700, Miami FL 33131.

B. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged and in full force and effect.

C. The Corporation has no members. The foregoing amendment was approved and ratified by a majority vote of the Board of Directors effective December 1, 2022 in accordance with Section 617.1002 of the Florida Statutes and the Corporation's Bylaws. Therefore, the Secretary of State is hereby requested to approve and file these Articles of Amendment in accordance with Chapter 617 of the Florida Statutes.
