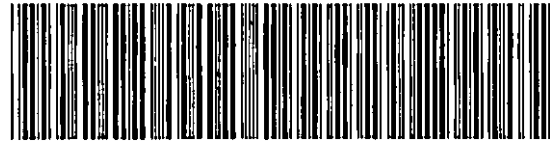

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a Florida nonprofit corporation, hereby adopts the following Articles of Incorporation:

**ARTICLE I.
NAME**

The complete legal name of this corporation shall be **FIREFIGHTER TRAINING INITIATIVE INC.**

**ARTICLE II.
PRINCIPAL OFFICE AND/OR MAILING ADDRESS**

DURATION**
