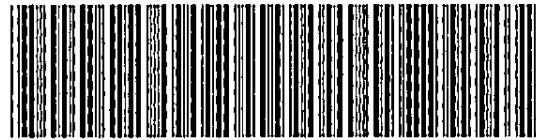

****Article III is ammended to read as follows:**

"The specific purpose for which this corporation is orgnaized is a faith based organization providing local and global humanitarian aid to at-risk, unhoused individuals and families."

"Said organization is organized exclusively for charitable, religious, and educational purposes. Such activities are within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States

Internal Revenue Law. Notwithstanding any other provision of these articles, this corporation shall not engage in any activities or exercise in any powers that are not in furtherance of the purpose of this corporation, and the corporation shall not carry on any other activities not permitted by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code. No substantial part of the activities of this corporation shall consist of lobbying or propaganda, or otherwise attempting to influence legislation."

**Article VIII is amended to read as follows:

"The effective date of this corporation is 01/05/2023"

"Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to either (i) such organization organized and operated exclusively for public and charitable purposes, which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code."
