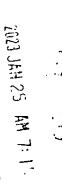

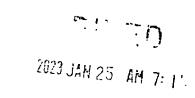

#### Purpose:

Books4Kids Jamaica, Inc is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. At Books4Kids Jamaica, we believe that taking the time to meet each child to give them their own book bag significantly increases their interest and enthusiasm for learning, and above all, shows them that they are important to us. With this simple gesture, we show that they matter, that going to school can be exciting and that we have faith in their academic abilities and their future.

#### Dissolution:

Upon termination or dissolution of the Books4Kids Jamaica, Inc, any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of the Books4Kids Jamaica, Inc hereunder shall be selected by the discretion of a majority of the managing body of the Books4Kids Jamaica, Inc and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against the Books4Kids Jamaica, Inc by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.
