ARTICLES OF INCORPORATION
(Not for Profit)
OF

Article I – Name

The name of the Corporation shall be L'Union Fait La Force Training Center, Inc.

Article II – Address of Corporation

The principal address of the Corporation and the mailing address shall be:

Article III - Purpose

The specific purpose for which this Corporation is organized is to train and develop young athletes from Haitian descent in order to prepare them to play soccer for the Haitian youth national team, or to play the sport at the college or professional level. In order to further the aforementioned objective, the Corporation will engage such young soccer athletes in a variety of activities. Such activities, as sponsored by the Corporation, will include, but will not be limited to, organized training, soccer camps, and the trainees participation in international tryouts.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Article IV – Manner of Election

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.


