CORPORATION OF
ON THE WAY STUDIOS, INC.

THE UNDERSIGNED SUBSCRIBER TO THESE ARTICLES OF INCORPORATION IS A NATURAL PERSON COMPETENT TO CONTRACT AND HEREBY FORM A NON-PROFIT CORPORATION UNDER CHAPTER 617 OF THE FLORIDA STATUTES.

ARTICLE I - NAME

THE NAME OF THE CORPORATION IS ON THE WAY STUDIOS, INC. (HEREINAFTER "CORPORATION")

ARTICLE II - PURPOSE OF CORPORATION

THE CORPORATION IS ORGANIZED FOR BUILDING TOMORROW'S LEADERS THROUGH THE PROCESS OF SELF-DEVELOPMENT AND MUSIC. ALLOWING STUDENTS TO BE IN TUNE WITH THEIR CAREER PATHWAY BY PREPARING THE MIND OF POTENTIAL YOUNG UPCOMING ARTIST THROUGH ONE-ON-ONE ARTIST/STUDIO EXPERIENCE TO ENTAIL THE BRIGHT BUT ALSO CHALLENGING FUTURE AHEAD. THE CORPORATION IS ALSO FOR CHARITABLE, RELIGIOUS, EDUCATIONAL, AND SCIENTIFIC PURPOSES, INCLUDING, FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501(C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

ARTICLE III - PROHIBITIONS

NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO ITS MEMBERS, TRUSTEES, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF THE PURPOSES SET FORTH IN ARTICLE SECOND HERE OF. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE CORPORATION SHALL NOT PARTICIPATE IN, OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OR IN OPPOSITION TO ANY CANDIDATE

FOR PUBLIC OFFICE. NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON (A) BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C) (3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR (B) BY A CORPORATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170(C) (2) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

ARTICLE IV - DIRECTORS

THE DIRECTORS SHALL BE ELECTED BY A MAJORITY VOTE OF THE MEMBERS OF THIS CORPORATION. THE DIRECTORS OF THE CORPORATION SHALL BE:

ARTICLE X - QUALIFICATIONS OF MEMBERSHIP

THE CATEGORIES OF MEMBERSHIP, QUALIFICATIONS FOR MEMBERSHIP AND THE MANNER OF ADMISSION SHALL BE SET FORTH IN AND REGULATED BY THE LAWS OF THE CORPORATION.

ARTICLE XI - VOTING RIGHTS

MEMBERS OF THE CORPORATION WILL HAVE SUCH VOTING RIGHTS AS ARE PROVIDED IN THE LAWS OF THE CORPORATION.

ARTICLE XII - LIABILITIES FOR DEBTS

NEITHER THE MEMBERS NOR THE MEMBERS OF THE BOARD OF DIRECTORS OR OFFICERS OF THE CORPORATION SHALL BE LIABLE FOR THE DEBTS OF THE CORPORATION.

ARTICLE XIII - REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE XIV - EFFECTIVE DATE

ARTICLE XV - AMENDMENT

EVERY AMENDMENT SHALL BE APPROVED BY THE BOARD OF DIRECTORS, PROPOSED BY THEM TO THE MEMBERS, AND APPROVED AT A MEMBERS MEETING BY A MAJORITY OF THE MEMBERS, UNLESS ALL THE DIRECTORS AND ALL THE MEMBERS SIGN A WRITTEN STATEMENT MANIFESTING THEIR INTENTION THAT A CERTAIN AMENDMENT OF THESE ARTICLES OF INCORPORATION BE MADE.

ARTICLE XVI - DISSOLUTION

UPON DISSOLUTION OF THE CORPORATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C) (3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT FOR PUBLIC PURPOSE. ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY COURT OF COMPETENT JURISDICTION OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE OF THE CORPORATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATIONS, AS SAID COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.
