**ARTICLES OF INCORPORATION
OF
FLORIDA'S UNIQUE EDUCATION LEARNING SUPPORT, INC.**

The undersigned, on behalf of the corporation set forth below, pursuant to Chapter 617 of the Florida Statutes for a not-for profit corporation, states as follows:

ARTICLE I - NAME.

The name of the Corporation shall be Florida's Unique Education Learning Support, Inc. (the "Corporation").

ARTICLE II - PRINCIPAL ADDRESS.

The principal place of business of the Corporation shall be 7901 4th St N, Ste 300, St. Petersburg, Florida 33702.

ARTICLE III - PURPOSE.

The Corporation is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purpose of the Corporation is to ease the financial burden placed on educators of students receiving Exceptional Student Education (ESE) or being considered for these services in Florida's publicly-funded schools. The Corporation will support these educators by providing the necessary tools and resources to effectively meet the needs of their exceptional education students, while alleviating the financial strain placed upon them.

ARTICLE IV - EXEMPTION REQUIREMENTS.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code; or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V - MEMBERSHIP AND BOARD OF DIRECTORS.

This Corporation shall have no members.

The management of the affairs of the Corporation shall be vested in a Board of Directors. The directors shall elect their successors. No director shall have any right, title, or interest in or to any property of the Corporation.

The number of directors constituting the initial Board of Directors is three (3), and their names and addresses are as follows:

1. Melissa Ley, 2878 24th Ave N Street, Petersburg, FL 33713
2. Nicole Larson, 12405 Pathway Court, Riverview, FL 33569
3. Holly Owen, 9945 56th Way N, Pinellas Park, FL 33782

ARTICLE VI - DURATION AND DISSOLUTION.

The term of existence of the Corporation is as perpetuity until dissolution. Upon the dissolution of the Corporation, its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or of the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


ARTICLE VII - REGISTERED AGENT.
