## ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

### ARTICLE I      NAME

The name of the corporation shall be Sickles Theatre Boosters, Inc.

### ARTICLE II      PRINCIPAL OFFICE

### ARTICLE III      PURPOSE

The organization is organized and operated for the promote and support the Theatre Department and its auxiliary programs and activities, to create a better pupil, director and parent relationship; to assist the Artistic Director(s) in developing the best theatre department possible in the Hillsborough County School System and to administer to the Theatre Department's financial needs, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. This support will be accomplished by recruiting volunteers, raising funds, and hosting charitable events. All donations and contributions raised will help support in the growth of the Sickles High School Theatre Department, and be used for materials needed to help successfully create fantastic productions, including, but not limited to, payment for production rights, materials and sound equipment to help better the program. The organization will conduct fundraising, the types of which shall be determined, throughout the year to generate these funds.

The corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code. (All references to sections in these Articles refer to the Internal Revenue Code of 1986 as amended or to comparable sections of subsequent internal revenue laws.) In pursuance of these purposes, it shall do all things necessary, proper, and consistent with maintaining tax exempt status under section 501 (c)(3).

### ARTICLE IV      MANNER OF ELECTION

**ADDITIONAL PROVISIONS**

No part of the net earnings of the corporation shall inure to the benefit of or be distributed to any director, employee or other individual, partnership, estate, trust or corporation having a personal or private interest in the corporation. Compensation for services actually rendered and reimbursement for expenses actually incurred in attending to the affairs of this corporation shall be limited to reasonable amounts. No substantial amount of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and this corporation shall not intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles or of any Bylaws adopted thereunder, this corporation shall not take any action not permitted by the laws which then apply to this corporation.

Upon dissolution of the corporation, its assets shall be disposed of exclusively for the purposes of the corporation or distributed to such organizations organized and operated exclusively for charitable purposes which shall, at the time, qualify as exempt organizations under section 501(c)(3), or shall be distributed to the federal government, or to a state or local government, for a public purpose.

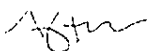
