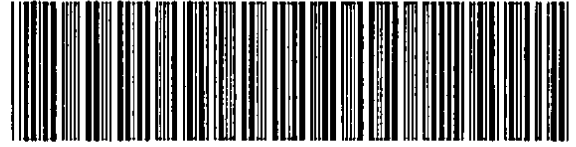

ARTICLES OF INCORPORATION

Locals Mix Creative Corp.

The undersigned incorporators hereby form a not for profit corporation in compliance with Chapter 617, Florida Statutes:

ARTICLE I – NAME

The name of the corporation will be Locals Mix Creative Corp.

ARTICLE II – PRINCIPAL OFFICE

The principal street address and mailing address of the corporation will be 125 Basin Street, Suite 206, Daytona Beach, Florida 32114.

ARTICLE III – PURPOSE

Locals Mix Creative Corp. is organized exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code", which each reference to a section of the Code to include the corresponding provisions of any future federal internal revenue laws), including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. By way of example, and not limitation, Locals Mix Creative Corp.'s purposes include to:

- a) Provide, encourage and support the arts, including visual, musical and performing art and art education in Daytona Beach and the surrounding area;
- b) Offer educational, social and multi-media material and events, including philanthropic activities, to support the community and local artists and musicians and to carry on such related activities that are permitted for corporations not for profit under the laws of the State of Florida and which are exempt from Federal income tax under section 501(c)(3) of the United States Internal Revenue Code of 1986 or the corresponding provisions of any future United States law.

ARTICLE IV – MANNER OF APPOINTMENT

The initial directors of Locals Mix Creative Corp. will be appointed as follows:

Initial Directors as set forth in Article IV hereof, are appointed. Additional Directors may be appointed by a majority vote of the serving Directors. All other matters pertaining to Directors, including number, qualifications, terms, groups, eligibility, and elections shall be prescribed by the Bylaws of Locals Mix Creative Corp. ("Bylaws").

The Board of Directors will adopt the initial Bylaws and the Board of Directors will have the power to alter, amend or repeal the same or adopt new Bylaws.

The management of the business and the conduct of the affairs of the corporation are vested in its Board of Directors. Except as otherwise provided in these Articles of Incorporation, each Director of Locals Mix Creative Corp. is entitled to one vote per Director on all matters voted or acted upon by the Board of Directors.



ARTICLE VI – REGISTERED OFFICE AND AGENT

ARTICLE VII – EFFECTIVE DATE

The effective date of Locals Mix Creative Corp. is October 1, 2022.

ARTICLE VIII – POWERS AND RESTRICTIONS

Locals Mix Creative Corp. is organized as a corporation not for profit and will not issue

shares of stock, will not pay dividends, and no part of the assets or net earnings of Locals Mix Creative Corp. will inure to the private benefit of any director, officer, or other individual. Notwithstanding the foregoing, Locals Mix Creative Corp. may pay compensation in a reasonable amount to its agents or employees for services rendered.

Locals Mix Creative Corp. will not make any distribution upon dissolution or final liquidation except as provided herein. Locals Mix Creative Corp. is organized and will be operated as an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States internal revenue law (the "Code"), and it may engage only in activities that may be carried on by a corporation exempt from federal income taxation.

No substantial part of the activities of Locals Mix Creative Corp. will be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation will not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, Locals Mix Creative Corp. will not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (ii) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX – MEMBERS

The membership of Locals Mix Creative Corp. will consist of any individual, corporation or other legal entity who subscribes to the general nature and purposes of the corporation.

ARTICLE X – DISSOLUTION

In the event of dissolution of Locals Mix Creative Corp., assets will be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or will be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of will be disposed of by a court of competent jurisdiction of the city or county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as the court will determine, which are organized and operated exclusively for such purposes.

ARTICLE XI – LIMIT ON LIABILITY AND INDEMNIFICATION

Locals Mix Creative Corp. will indemnify and hold harmless each of its Directors, Officers, employees, and agents (and his or her executor, personal representative, and heirs), whether or not then in office, who were or are a party or are threatened, pending or completed action, suit or proceeding, whether civil, criminal administrative or investigative (including an action or suit by

or in the right of Locals Mix Creative Corp.) by reason of the fact that the person is or was a Director, Officer, employee or agent of Locals Mix Creative Corp., against expenses (including all attorneys' fees), judgments, fines and amounts paid in settlement incurred by the person in connection with such action, suit or proceeding, unless there is a final adjudication by a court of competent jurisdiction that such person is liable for willful misconduct or a knowing violation of criminal law. All attorneys' fees and costs will be reimbursed immediately by Locals Mix Creative Corp. as they are incurred by such person, and promptly will be repaid to Locals Mix Creative Corp. only upon a final adjudication by a court of competent jurisdiction that such person is liable for willful misconduct or a knowing violation of criminal law. The right to indemnification is set forth in this Articles is in addition to and not exclusive of, all other rights to which such Director, Officer, employee or agent may be entitled, including but not limited to any rights under policies of insurance that may be purchased and maintained by Locals Mix Creative Corp.

ARTICLE XII - AMENDMENTS


