To Whom It May Concern:

I am writing this letter to provide some clarity on my nonprofit corporation. My corporation appears on Sunbiz already, and it is incorrectly filed as a "Foreign Not For Profit Corporation".

I recently move my business from California to Florida. Four months ago, I called into Sunbiz to inquire about how to domesticate my entity to Florida, and the below is what was told to me:

*"Informed me that for-profit corporation can file a Conversion to basically domesticate in FL. but this does not work for a nonprofit. They said this is a recent change and what I would have to do is file a new article of incorporation as a foreign entity in FL, then dissolve corporation in original home state"*

I went ahead and executed that based on what the representative told me. However, I most recently called in and spoke to someone who advised me of the correct form to file "Certificate of Domestication".

Please convert my nonprofit corporation to a true domestication. I included this letter to provide clarity in the event there was confusion regarding my current status.
