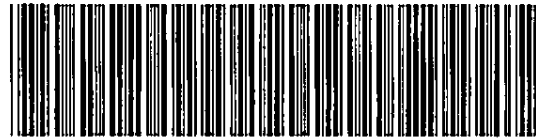

Articles of Incorporation of FREEDOM'S REST, Inc.

The undersigned, acting as the incorporator of a corporation pursuant to Chapter 617 of the Florida Statutes, the Florida Not-For-Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE 1: NAME:

The name of the corporation shall be FREEDOM'S REST, INC.

ARTICLE 2: PRINCIPAL OFFICE

The street address and mailing address of the principal place of business of the corporation is 1805 PRAIRIE GRASS LANE, VALRICO, FL 33594

ARTICLE 3: PURPOSE

This corporation is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law), including, but not limited to, for such purposes, to provide assistance to replenish, restore, and financially assist individuals; to provide faith-based training; and engaging in any other activity not prohibited to corporations under the Florida Not-For-Profit Corporation Act that is in furtherance of Section 501(c)(3) purposes.

ARTICLE 4: MEMBERS

The corporation shall have members. The qualifications, rights, privileges, duties, and classifications of members of the corporation shall be stated in the bylaws of the corporation.

ARTICLE 5: MANNER OF ELECTION

The corporation shall have a minimum of three (3) directors. The qualifications, duties, and election of directors shall be stated in the bylaws of the corporation.
