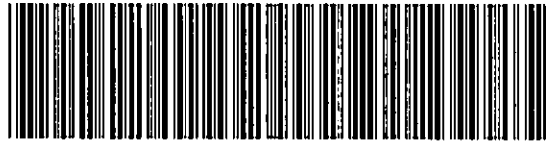

Article I NAME:






