## ARTICLES OF INCORPORATION OF Chester Community Church, Inc. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

#### ARTICLE I NAME

The name of the corporation shall be: Chester Community Church, Inc.

#### ARTICLE II PRINCIPAL OFFICE

#### ARTICLE III PURPOSE

- (1) Primarily, the organization is formed exclusively for charitable, educational, and religious purposes within the meaning of IRC Section 501(c)(3):
- (2) Specifically, the organization provides a place of worship for its members, who shall be members in good standing of the Church of God, Cleveland, Tennessee, and conducting the affairs for the congregation according to the rules and regulations of the Church of God, Cleveland, Tennessee, and specifically the General Assembly Minutes of the Church of God, Cleveland, Tennessee, promoting the cause of Christianity in accord with the teachings, tenets, and customs of the Church of God, Cleveland, Tennessee, receiving, managing, and disbursing gifts, bequests, and other funds for the benefit of the congregation and the Church of God, Cleveland, Tennessee; owning and maintaining suitable buildings and facilities necessary for their acquisition, upkeep, maintenance and sale, all in accord with the General Assembly Minutes of the Church of God, Cleveland, Tennessee.

- (3) Generally, to have and exercise all rights and powers conferred on nonprofit corporations under the laws of Florida, or which may hereafter be conferred, including the power to contract, rent, buy, or sell personal or real property:
- (4) Notwithstanding any of the above statements of purposes and powers, this corporation shall not engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation:
- (5) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof.
- (6) No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office:
- (7) In the event this corporation shall cease to exist, or depart from the polity of the Church of God. Cleveland, Tennessee, as expressed in the General Assembly Minutes of the Church of God. Cleveland, Tennessee, and otherwise, the assets of the corporation shall revert to the State Trustees for the Church of God in the state of Florida, or to one or more organizations described in Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any prior or future Internal Revenue Code. Further, that the proceeds/assets from the disposition must go the directly into real property purchases or improvements.
