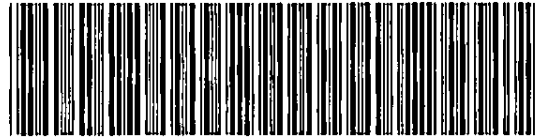

Articles of incorporation of the undersigned, all of whom are citizens of the United States, desiring to form a Non-Profit Corporation.

Article I

NAME/REGISTERED OFFICE

The name of this organization shall be: ANTIOCH BAPTIST CHURCH MELBOURNE

The organization's registered office shall be at: 105 RIVER CLIFF LANE MERRITT ISLAND, FL. US 32952. The mailing address of the organization shall be: 105 RIVER CLIFF LANE MERRITT ISLAND, FL. US 32952.

Article II

PURPOSE

The organization shall be organized exclusively for charitable, religious, and educational purposes to carry out the commands and doctrines of the Bible. Within the means of section 501(c)(3) of the Internal Revenue Code of 1988 as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(C)(3) exempt organizations.

The purposes of the Corporation shall be to proclaim that salvation from sin and eternal life in a close relationship with God is available to every person through the death of Jesus Christ and the power of His resurrection; to minister to the multitudes; to teach the precepts of Christian living particularly as applied in scripture; to support and encourage communication and extension of the Christian life and witness by sound and comprehensive preaching and teaching of the Holy Bible and of the Gospel of the Lord Jesus Christ to all people, both within this fellowship and elsewhere, not only by conventional modes, but also by all means which will accomplish such communication, extension, teaching and preaching, including but not limited to media of communication developed by modern technology; and in aid of such communication, extension, preaching and teaching, but not for private profit, to sponsor, participate in, conduct or engage in radio broadcasting, television broadcasting, internet and computer media broadcasting, the printing or reproducing and publication of recordings, books and other materials, the establishment and operation of a school or schools, and the holding and conducting of seminars, study groups, workshops and meetings, by either resident or traveling evangelists, teachers, or others; to receive offerings for such purposes; provide meals and clothing for the needy; and to grant aid and pay reasonable compensation for services actually rendered to persons, firms, and corporations for such purposes.

Article III
LIMITATIONS

At all times the following shall operate as conditions restricting the operations and activities of the organization:

1. No part of the net earnings of the organization shall inure to any member of the organization not qualify as exempt under section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any director, or officer of the organization, nor to any private persons, except solely such reasonable compensation that the organization shall pay for services actually rendered to the organization, or allowed by the organization as a reasonable allowance for authorized expenditures incurred on behalf of the organization.
2. No substantial part of the activities of the organization shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the organization shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
3. Notwithstanding any other provisions of these articles, the organization shall not carry on any other activities not permitted to be carried on by a organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.
4. The organization shall not lend any of it assets to any officer or director of this organization or guarantee to any person the payment of a loan by an officer or director of this organization.

ARTICLE IV
DIRECTORS/MEMBERS

The organization shall have no voting members. The management and affairs of the organization shall be at all times under the direction of the Board of Trustees, whose operations in governing the organization shall be defined by the statute and by the organization's by-laws. No director or officer shall have any right, title, or interest in or to any property of the organization.

The organizations initial board of trustees shall be comprised of the following natural persons:

Treasurer- Jonathan S. Atienza 391 Park Avenue Satellite Beach, Florida 32937

The initial Board of Trustees shall serve until December 31, 2027, and will be eligible for re-election as per the by-laws, at that meeting.

ARTICLE V
DEBT OBLIGATIONS AND PERSONAL LIABILITY

No officer or Director of this organization shall be personally liable for the debts or obligations of this organization of any nature whatsoever, nor shall any property of the officers be subject to the payment of the debts or obligations of this organization.

ARTICLE VI
DISSOLUTION

Upon dissolution of the organization, assets shall be distributed to Banana River Baptist Church, a 501(c)(3) organization; FEIN 47-4924918.

ARTICLE VII
TAX IDENTIFICATION NUMBER

The FEIN for ANTIOCH BAPTIST CHURCH MELBOURNE INC. shall be 92-1096525


ARTICLE VIII
