

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be the Community Development Foundation of Jay, Incorporated

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The Community Development Foundation of Jay, Incorporated shall serve as an economic development corporation to provide assistance, including, but not limited to, grants, loans and provision of information and expertise, to stimulate and assist economic development in economically depressed or blight areas of the Town of Jay, Florida; an Economically Distressed Rural Community located in an Urban County as designated the Florida Department of Economic Opportunity.

ARTICLE IV MANNER OF ELECTION
