**ARTICLES OF DISSOLUTION**

Barrier Dunes-Seacliffs Sewage Treatment Facility, Inc. (Corporation Number N22126), files these Articles of Dissolution pursuant to Section 617.1403, Florida Statutes, and asserts as follows:

1. The name of the corporation is Barrier Dunes-Seacliffs Sewage Treatment Facility, Inc.
2. The Articles of Incorporation of the corporation provide in Article XI that the term of the corporation's existence will "cease upon the intervention of the proper city and/or county governing officials of Gulf County, Florida, to provide sewage treatment services to Cape San Blas, Florida."
3. On June 23, 2011, the City of Port St. Joe, Florida, finalized the installation of sewage treatment services to the property previously serviced by the corporation on Cape San Blas, Florida.
4. The corporation has wound down all of its business activities and distributed remaining assets in accordance with the terms of the Articles of Incorporation.
5. There are no members entitled to vote on the dissolution of the corporation (which stands dissolved by terms of the Articles of Incorporation its purposes and term having been completed) and the Board of Directors has approved the Dissolution.

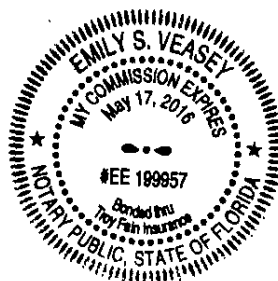




**RESOLUTION**
