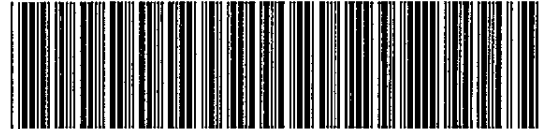

**ARTICLES OF DISSOLUTION
OF FRONTLINE MISSIONS, INC.**

Pursuant to the provisions of Sections 617.1402 and 617.1403 of the Florida Statutes, the undersigned Florida not for profit corporation hereby adopts the following Articles of Dissolution:

Article I - Name of Corporation

The name of the corporation is FRONTLINE MISSIONS, INC. (hereinafter referred to as the "Corporation").

Article II - Date Dissolution Authorized

The dissolution of the Corporation was authorized on October 19, 2004.

Article III - Approval of Dissolution

No members of the Corporation are entitled to vote on its dissolution. The dissolution was approved by all six members of the Board of Directors of the Corporation by telephone conversation on October 19, 2004 pursuant to Section 617.0821 of the Florida Statutes.
