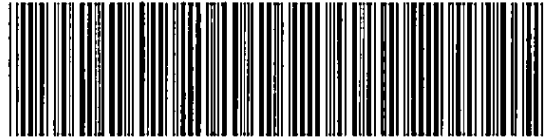

ARTICLES OF AMENDMENT
TO
WEST ORANGE BAPTIST CHURCH, INC.'S
ARTICLES OF INCORPORATION

Pursuant to Section 617.1001, Florida Statutes, the Articles of Incorporation of West Orange Baptist Church, Inc. (the "Corporation") are amended as follows:

1. The last paragraph of Article III is deleted and replaced with:

In the event that this Corporation is dissolved, upon dissolution, and subject to the provisions of Florida Statute 617.1406, the Corporation's assets, both real and personal, shall be distributed to any not for profit corporation duly existing and organized under the laws of the State of Florida engaged in a ministry substantially similar to that of the Corporation as the Members of the Congregation and the Board of Trustees of may designate.

2. The above Amendment was adopted by the Board of Trustees of the Corporation through an Action by Consent dated August 9, 2023 and the Members of the Congregation entitled to vote thereon at a special meeting of the Members of the Congregation held August 9, 2023, pursuant to Section 617.1002.
