ARTICLE IV PURPOSE AND POWERS OF THE ASSOCIATION

D. Borrow up to five hundred thousand dollars (\$500,000,00) without money, and with the vote of the members provided that the vote of the board of directors is at least two-thirds (66 2/3rds) of the sitting directors entitled to vote. Any loan that exceeds five hundred thousand dollars (\$500,000,00) requires the consent assent of two-thirds (2/3) of the members present in person or by proxy at a meeting called for that purpose, at which a quorum is established, mortgage, pledge, deed in trust, or hypothecate any of all of its real or personal property as security for money borrowed or debits incurred; Once the board of directors or the members have approved the Association borrowing money, the board of directors is authorized to pledge as collateral the real or personal property of the Association to secure repayment of the loan. Funds may only be borrowed to pay emergency expenses such as, but not limited to, repair of hurricane damage.
