In or around 1988, my then husband (now deceased) Edward F. Korinchak and I purchased a lot in Thousand Oaks Estates First Addition in Pensacola, Florida from Medford L. Starratt, Jr. In spite of closing at a title company we subsequently discovered that Mr. Starratt did not own the property outright but rather had a mortgage on the property which he was not paying. We were made aware of the fact when we received foreclosure papers on our lot for which we had paid Mr. Starratt. It was at that point that any and all of our business dealings with Mr. Starratt ended.

Neither my husband nor I were aware that Mr. Starratt had formed the Thousand Oaks Estates Homeowners' Association, Inc. and filed papers naming my husband and me as Directors. As far as I know, we were the first and only people to purchase a lot there and no homes were built there prior to the foreclosure. I am not sure why a homeowners' association would have been needed, but my husband and I had no knowledge of, nor did we ever consent to being a part of, said association, much less to hold offices as directors.

After contacting one of your representatives I was sent a resignation form so that I may resign from an office I never consented to, in an association whose existence was unknown to me. I am including the form for me along with the required \$35.00 fee (unbelievable considering the circumstance), but any recessor in the circumstance of the circu

It appears to me from this case that perhaps the procedures for filing paperwork for such associations should be revised to include notarized signatures from the parties involved to make sure that people have knowledge of and have consented to the offices they are recorded as holding.
