ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION

OF

GREEN ISLE FOUNDATION, INC.  
a Corporation Organized for Charitable Purposes

Pursuant to the provisions of Section 617.1001 and 617.1002, Florida Statutes,  
the undersigned corporation submits the following articles of amendment:

1. The name of the corporation is GREEN ISLE FOUNDATION, INC.
2. There are no members of the corporation entitled to vote on the articles  
of amendment to the articles of incorporation.
3. The following amendments to the articles of incorporation were adopted  
by the board of directors on May 25, 1999:


ARTICLE XV-DISSOLUTION

In the event of dissolution, voluntarily or by operation of law, all of the residual  
assets of the corporation will be turned over to one or more corporations which  
themselves are exempt as corporations described in Sections 501(c)(3) and 17(c)(2) of  
the Internal Revenue Code of 1986 or corresponding sections of any prior or future  
Internal Revenue Code, or to the Federal, State or local government for exclusive  
public purposes. Preference shall be given to qualifying Florida Christian groups caring  
for children, preferably a Florida Association Christian Child Caring Agencies


3. The above stated amendment shall become effective on May 25, 1999.
