INCORPORATED**

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: The following articles are being amended:

Article III : Purpose

To group together, direct and organize institutions that practice Allan Kardec Spiritualist philosophy. To educate the institutions or their moral and spiritual obligations in the community. In addition:

- A. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of sections 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

Article VIII: Dissolution

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, or local government for exclusive public purpose.

Amendment – Kardecian Spiritism Federation of Florida Incorporated

SECOND: The date of each amendment's adoption is January 29, 2000.

THIRD: The amendments were approved by the members and directors. The number
Of votes Cast for the amendments were sufficient for aproval.
