

PLAN OF DISTRIBUTION OF ALTAMONTE SPRINGS EMPLOYEES ORGANIZATION, INC.

This Plan of Distribution (this "Plan"), dated as of December 16, 2022 (the "Plan Date") and pursuant to Section 617.1406, Florida Statutes, is intended to provide for the distribution of assets in connection with the dissolution of the Altamonte Springs Employees Organization, Inc., (the "ASEO"), a Florida not for profit corporation.

The directors of the ASEO (the "Directors") met on December 6, 2022, and voted that the ASEO be dissolved. The ASEO shall be dissolved on the December 31, 2022 (the "Effective Date").

On and after the Effective Date, the ASEO shall liquidate the ASEO's assets in accordance with the terms of this Plan. This action by and on behalf of the ASEO does not require further approval by the Directors and may include efforts such as:

- (a) All liabilities and obligations of the ASEO shall be paid and discharged, or adequate provisions be made therefor;
- (b) Any assets held by the ASEO upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirements;
- (c) Any assets received and held by the ASEO subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution, shall be transferred or conveyed to one or more domestic or foreign corporations, trusts, societies, or organizations engaged in activities substantially similar to those of the dissolving corporation, as provided in the plan of distribution of assets;
- (d) Other assets, if any, shall be distributed in accordance with the provisions of the articles of incorporation or the bylaws to the extent that the articles of incorporation or the bylaws determine the distributive rights of members, or any class or classes of members, or provide for distribution to others; and
- (e) Any remaining assets be distributed to such persons, trusts, societies, organizations, or domestic or foreign corporations, whether for profit or not for profit, as specified is this Plan.

The Directors do herey declare no assests of the ASEO will exist on or after the Effective Date.
