The following Amendment to Articles of Incorporation of Catholic Hospice, Inc., a Florida not for profit corporation was duly adopted by unanimous vote of the Member(s) and at which the number of votes cast was sufficient for approval, pursuant to the authority and provisions of Florida Statutes and the existing Articles of Incorporation, as amended from time to time. This Amendment is also in conformity with the Bylaws of Catholic Hospice, Inc. and no further action is necessary for its approval.

BE IT RESOLVED that Article II, paragraph (a), shall be amended, effective with the date of filing of this Amendment with the Secretary of State, effective to read as follows:

ARTICLE II PURPOSE

(a) The specific and primary purposes of the Corporation shall be to sponsor services for the terminally ill, including, but not limited to, providing hospice services especially designed to meet the physical, social and psychological needs of the terminally ill and to manage, operate and generally to do everything and anything necessary, expedient or incidental, to the maintaining of hospice activities in Miami-Dade County, Broward County, Monroe County, Palm Beach County and any other location in which the Corporation is authorized to provide services.
