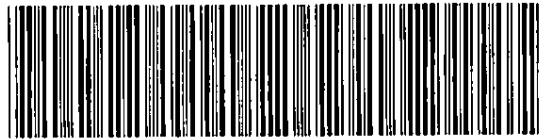


ARTICLE VIII

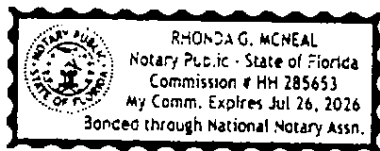



