The purpose for which the corporation is organized is to provide for the preservation of the values, amenities, attractiveness and desirability of real property known as **FRONT PORCH FARMS** located in Range-1 East, Leon County Florida being more particularly described as follows:

COMMENCE at a Concrete Monument marking the Northwest Corner of Section 23, Township-2-North, Range-1-East, Leon County, Florida, and run thence North 88 degrees 46 minutes 20 seconds East along the North boundary of said Section 23 a distance of 2565.01 feet, thence South 779.87 feet to the POINT OF BEGINNING.
