ARTICLES OF INCORPORATION

ARTICLE IV MANNER OF ELECTION The manner in which the directors are elected and appointed:

The initial Board of Directors shall consist of four members and hold office for 3 years, except for the initial term which shall be indicated following their names below. Each director shall be elected by a majority of the remaining directors at the annual meeting in which his or her position is scheduled to be filled.
