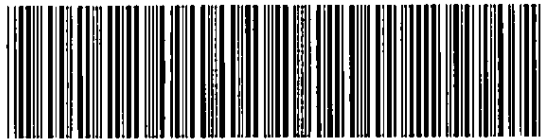

I hope this email finds you well. I am following up on a Non-Profit Corporation filing under the name "Blow The Whistle, Incorporated" submitted via mail on October 14, 2022, with the Document Number: W22000139293. I called the Division of Corporations on November 10, 2022 in efforts to follow up on the filing, and was advised I would receive the rejection letter via mail with a Tracking Number and Pin to make the necessary amendments, specifically to the name as there is a Limited Liability Company with a common name. The representative forewarned me the Division was a bit delayed in processing and that I would receive the letter within a month. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
