ARTICLES OF INCORPORATION OF HUSSEIN FAMILY FOUNDATION, INC.

These Articles of Incorporation are hereby made and acknowledged by the undersigned, to be filed with the Secretary of State, State of Floridu, for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida.

ARTICLE 1

Name and Address

The name of the corporation shall be HUSSEIN FAMILY FOUNDATION, INC. (a)

(b) The street address of the initial principal office of the corporation shall be 3333 W. Kennedy Boulevard, Suite 204, Tampa, Florida 33609.

ARTICLE II Term of Existence.

The corporation shall have perpetual existence. ARTICLE III

Purposes; restrictions

Subject to the restrictions set forth in paragraph (b), the purposes for which the (a) corporation is organized are to receive and administer real and personal property and to apply. such property, as well as the income it produces, exclusively for charitable, religious, scientific; -> literary and educational purposes, either directly or by contributions to organizations that qualify". as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 and the corresponding provisions of any subsequent Federal tax laws.

Despite any contrary provision of these Articles: (b)

No part of the net earnings of the corporation shall inure to the benefit of (1)any director or officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation, affecting one or more of its purpeses).

No director or officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

No substantial part of the activities of the corporation shall be the carrying (3)on of propaganda or otherwise attempting to influence legislation. The corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

(4) The corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1986, or the corresponding provision of any subsequent Federal tax laws.

(5) The corporation shall distribute its income for each taxable year at such time and in such manner as not be become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1986, or the corresponding provisions of any subsequent Federal tax laws.

(6) The corporation shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1986, or the corresponding provisions of any subsequent Federal tax laws.

(9) The corporation shall not engage in any prohibited transaction as defined in Section 503(b) of the Internal Revenue Code of 1986, or the corresponding provisions of any subsequent Federal tax laws.

(10) Despite any other provision of these Articles or Florida law, the <u>corporation shall</u> not carry on any activities not permitted for an organization exempt under Sections 501(a) and 501(c)(3) of the Internal Revenue Code of 1986 or the ^{corresponding} provisions of any subsequent Federal tax laws, or by organizations, \approx contributions to which are deductible under Section 170(c)(2) of such Code.
