ATTACHMENT TO ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF I WANNA THANK YOU MINISTRIES, INC.

Article III:

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, inclu for such purposes, the making of distributions to organizations that qualify as exempt organizations under se 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific purpose of this corporation is to help the community form a relationship with God and also pre helpful services to the needy.

Article IX:

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its trust officers, or other private persons, except that the organization shall be authorized and empowered to pay real able compensation for services rendered and to make payments and distributions in furtherance of the purposet forth in the purpose clause hereof.

No substantial part of the activities of the organization shall be the carrying on of propaganda, or others attempting to influence legislation, and the organization shall not participate in, or intervene in (including publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, conbutions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding sect of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. A such assets not disposed of shall be disposed of by the Court of Common Pleas exclusively for such purposes to such organization or organizations, as said Court shall determine which are organized and operated exclusive for such purposes.
